

# Kwong Fong Industries Corporation

## Privacy Policy

Kwong Fong Industries Corporation and its subsidiaries (hereinafter collectively, the “Group,” “we,” or the “Company”) are committed to respecting and protecting personal privacy and personal data. In compliance with applicable laws and regulations, this Privacy Policy (the “Policy”) is established to explain how personal data are collected, processed, used, and protected. We hereby declare and undertake to comply with this Policy to safeguard the rights and interests of data subjects.

### I. Scope of Application

This Policy applies to the Group and its customers, suppliers, contractors, external consultants, investors, job applicants, visitors to the Group’s websites, and any other individuals or entities that have business dealings with the Group.

### II. Collection of Personal Data

We may collect or obtain your personal data under the following circumstances: when you provide information to the Company; when information is obtained based on a legal relationship between you and us; when personal data is publicly disclosed by you; when you visit the Company’s websites; when you register on any of the Company’s websites to use our websites, products, or services; or when you interact with third-party content or advertisements on our websites. In addition, we may obtain your personal data from third parties.

### III. Personal Data Created by the Company

In certain circumstances, the Company may create personal data relating to you, such as records of your interactions or past interactions with us. The Company may combine personal data obtained from websites, products, or services, including data collected from different devices, for record-keeping and use.

### IV. Categories of Personal Data Processed

The Company may process the following categories of personal data: personal information; demographic information; contact information; records of consent obtained; order details; payment information; information related to the Company’s websites; employer information; information regarding your interaction with website content and advertisements; opinions and feedback provided by you; communication records between you and us; and cookie data.

### V. Special Categories of Personal Data

In the ordinary course of business, the Company does not proactively collect or process special categories of personal data. Where it is necessary to collect or process such data for lawful purposes, the Company will do so only within the scope of the following purposes and

in accordance with applicable laws and regulations:

Compliance with Legal Obligations: Where required or permitted by applicable laws and regulations, the Company may collect and process special categories of personal data.

Investigation or Prevention of Criminal Activities: Where necessary for the investigation, detection, or prevention of criminal activities, the Company may process such personal data.

Establishment, Exercise, or Defense of Legal Rights: Where necessary for the establishment, exercise, or defense of legal claims or rights, the Company may process such personal data.

Consent of the Data Subject: Where prior explicit consent has been obtained from you in accordance with applicable laws, the Company may collect and process your special categories of personal data.

When providing special categories of personal data to the Company, you confirm that you are legally authorized to disclose such information to us.

## VI. Purposes and Legal Basis for Processing Personal Data

We process your personal data for the following purposes: provision of websites, products, and services; compliance reviews; business operations; communication with you; information system management; supplier management; health and safety; financial management; surveys and feedback collection; ensuring system security; judicial investigations; compliance with applicable laws; improvement of our websites, products, and services; fraud prevention; assertion, exercise, or defense of legal rights; and recruitment and hiring activities.

## VII. Recipients of Personal Data

The Company may share your personal data with the following third parties: competent authorities; external advisors; service providers; third parties where disclosure is required for litigation or other legal proceedings; third parties where disclosure is necessary for investigation, detection, or prevention of criminal activities; third parties acquiring all or part of our business or assets; and third parties providing advertisements, plug-ins, or website content.

## VIII. Your Rights

In accordance with applicable laws and regulations, you may exercise the following rights with respect to your personal data:

The right to refuse the provision of personal data;

The right to access and review your personal data;

The right to request correction or rectification of inaccurate personal data;

The right to request deletion of personal data;

The right to request restriction of the processing of personal data;

The right to object to the processing of personal data;

The right to request the transfer or portability of your personal data to another data controller, where applicable;

The right to withdraw your consent at any time; and

The right to lodge a complaint with the competent data protection authority.

In certain circumstances, you may be required to provide appropriate identification documents in order to exercise the above rights.

Subject to applicable laws and regulations, you further have the right to:

Object, based on your particular situation, to the processing of your personal data by the Company or by third parties processing such data on the Company's behalf; and

Object to the processing of your personal data by the Company or by third parties acting on the Company's behalf for direct marketing purposes.

#### IX. Use of Customer Data Beyond the Stated Purpose

The Company is committed to protecting customer privacy and will not use collected customer information beyond the purposes specified in this Policy.
