In order to prevent dishonest behavior, the company has formulated " Measures for the Report on Illegal, Unethical and Dishonest Conducts " and " Procedures for Ethical Management and Guidelines for Conduct". It has established a reporting mechanism, which is accepted by the spokesperson and audit supervisor and dealt with clearly. program.
